26	Approval of the Minutes
27	Gillespie moved to approve the March 26, 2024 minutes. Seconded by Capogrossi.
28	Ayes: Baker, Capogrossi, Fournier, Gillespie and Schleelein.

31	Public Comment Period:
32	Susan Ainslie as Trustee liaison. Carla Marceau is observing for the Community Party.

34	Schleelein moved to close the Public Comment period. Seconded by Capogrossi.
35	Ayes: Baker, Capogrossi, Fournier, Gillespie and Schleelein.

38	Baker read the following agenda item:

40	<u>Discussion of Possible Tree Law Changes</u>
41	Baker has some notes that he and Schleelein had discussed as possible changes to the Tree Law
42	as well as some comments from Fournier. As the Planning Board goes through the Tree Law,

Baker will inject these comments.

- 45 The Planning Board discussed the section relating to clearing over 25% of the trees over a 3-year
- 46 period from a property and how to keep tract of this and if it is possible.
- 47 French commented that the intention of this section was to prevent clear cutting of an entire
- 48 property.
- 49 Fournier questioned if the overall intention of this section was for aesthetics or ecological
- 50 impact.
- 51 Schleelein feels that ecological and environmental concerns should be emphasized more and the
- 52 wonders if the purpose statement for the law captures that enough.
- 53 Baker stated that he feels the purpose statement does include ecological and environmental
- 54 concerns but, understands Schleelein concerns.
- 55 Schleelein also questioned whether items such as root structure should be included within the
- 56 law. This would prevent overcrowding of trees and provide a best-case scenario for growth.
- 57 The Planning Board discussed conveyance of stormwater from one property to another as a result
- 58 of removing or adding trees.
- 59 French stated that case law does not support a scenario where a resident removes a large tree
- 60 which results in the change of stormwater to a neighbor's property.

- 62 The Planning Board discussed the recommended \$1,250 tree planting value that had been
- 63 provided by John Courtney who told Scott that the DPW would have to pay prevailing wage to
- 64 do the planting and that the price also takes in consideration the tree care needed until that new
- 65 tree becomes established.
- 66 Baker stated that within the wording of the Tree Law, the Planning Board has the authority to
- 67 reduce that price. This was the case with Northeast Pediatrics because the facility has solar
- 68 panels installed on the roof. Should the Tree Law state something about offsetting the carbon
- 69 footprint by other means?
- 70 French feels that "offsetting" could be installed in the "Tree Bank" part of the law.

71

- 72 The Planning Board next discussed the exemptions for tree removal such as dead trees that may
- 73 cause damage to life or property. There was a concern about a developer who might poison or
- 74 intentionally harm trees on a developable property just to avoid the Tree Law obligations.

- 76 The Planning Board moved on to tree unit requirements and whether 30 tree units is the proper
- amount. Another possibility would be whether residential should be a different amount than
- 78 commercial.
- 79 Fournier suggested removing the required parking space and/or building space from the
- 80 calculated usable land for commercial properties.
- 81 Scott will calculate the required units for Northeast Pediatrics using Fournier's suggestion.

82

- 83 The Planning Board discussion turned to whether shrubs should count in the tree unit calculation.
- 84 There was a suggestion that a shrub percentage should be adopted and even a percentage for
- 85 deciduous versus evergreen trees.
- 86 French does not understand why a "buffer strip" is not calculated within the tree unit count.
- 87 The Planning Board discussed this and buffer strip responsibilities.
- 88 Fournier suggested adding "may" instead of "shall" when it comes to counting the trees of a
- 89 buffer strip toward total tree unit count.
- 90 The Planning Board talked about requiring a minor subdivision to conform to the Tree Law and
- 91 possibly removing any special permit that does not change the footprint of a building. A special
- 92 permit for a home occupation is one example.

- 94 The Tree Law discussion ended with comments on who is qualified to present a landscaping
- 95 plan, whether a stamped plan is necessary and how to calculate tree canopy calculations.

97 Trustee Report

- 98 Capogrossi gave a breakdown of the April 1st Board of Trustee Meeting
